Re: Compilation of Sources and Resources Regarding the Trump-Vance Administration’s Militarization of U.S. Cities

This resource compiles information on the Trump-Vance administration’s militarized operations in cities across the country, pursued under the guise of immigration enforcement. This memorandum is meant to serve as a quick guide that compiles relevant sources that the administration has relied on (including policies, executive orders, and other documents), press coverage of what is happening on the ground, as well as key litigation challenging these operations and helpful legal explainer materials. It is organized into two major categories of militarized operations: those led by the U.S. Department of Homeland Security (DHS), including operations undertaken by Immigration and Customs Enforcement (ICE) and Customs and Border Protection (CBP), and those led by the U.S. Department of Defense (DOD) in relation to the deployment of the National Guard. Within each category, the information and resources are organized by city. Given fast-moving events, this resource will be updated regularly.

The Militarization of Cities

Executive Actions

On June 7, 2025, **President Trump issued a Presidential Memorandum, “[The Department of Defense Security for the Protection of Department of Homeland Security Functions](#),”** which authorized the federalization and deployment of National Guard forces and active-duty armed forces to protect Immigration and Customs Enforcement (ICE) and other federal agents and federal property. The Memorandum invoked “violent protests” and “disorder” by opponents of ICE’s enforcement operations as the justification.

On September 25, 2025, **President Trump issued National Security Presidential Memorandum 7 (NSPM-7) “[Countering Domestic Terrorism and Organized Political Violence](#).”** The memo directs the National Joint Terrorism Task Force (JTTFs) and its local offices to “coordinate and supervise a comprehensive national strategy to investigate, prosecute, and disrupt entities and individuals engaged in acts of political violence and intimidation.”

On September 29, 2025, **Attorney General Bondi issued a memorandum to the Federal Bureau of Investigation (FBI), Drug Enforcement Administration (DEA), Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), U.S. Marshals Service (USMS), and Executive Office of U.S. Attorneys: “[Ending Political Violence Against ICE](#).”** The memo instructs the Department of Justice (DOJ) to direct officers and agents to defend ICE facilities, specifically in Portland and Chicago, add local law enforcement entities to a temporary ICE Protection Task Force, and provide grant funding, training, and technical assistance to support ICE law enforcement.

On [October 8, 2025](#), the **Pentagon’s National Guard Bureau of Operations issued a memo** ordering the formation of “Quick Reaction Forces” trained in “civil disturbance operations.” A leaked unclassified [version of the memo](#) obtained by *The Guardian* sets thresholds for the size of the forces to be trained in each state. Most states are directed to train 500 National Guard members, amounting to 23,500 troops nationwide.

Militarized Immigration Enforcement in Specific Cities

Executive Actions

The week of May 19, 2025, **Stephen Miller and the Department of Homeland Security (DHS) Secretary Noem directed ICE to [arrest 3,000 people per day](#).**

On June 4, 2025, **NBC News reported that ICE was planning to launch “[Operation At Large](#),”** a nationwide plan to ramp up arrests of undocumented immigrants. According to NBC News: “The plan calls for using 3,000 ICE agents, including 1,800 from Homeland Security Investigations, which generally investigates transnational crimes and is not typically involved in arresting noncriminal immigrants; 2,000 Justice Department employees from the FBI, the U.S. Marshals Service and the Drug Enforcement Administration; and 500 employees from Customs and Border Protection. It also includes 250 IRS agents, some of whom may be used to provide information on the whereabouts of immigrants using tax information, while others would have the authority to make arrests, according to the operation plan.”

On June 16, 2025, **President [Trump ordered ICE to increase deportation efforts in cities with Democratic leadership](#).** On TruthSocial, President Trump [told](#) ICE officers to “do all in their power to achieve the very important goal of delivering the single largest Mass Deportation Program in History.”

On September 9, 2025, **NBC News reported that [ICE has stopped requiring that officers complete certain paperwork before conducting an immigration arrest](#),** which seemingly facilitates a nationwide policy authorizing warrantless arrests in violation of 8 U.S.C. § 1357(a)(2).

On December 12, 2025, NewsNation [reported](#) that **DHS would be ceasing to conduct at-large raids and would instead focus on targeted arrests.**

On December 19, 2025, the Department of Homeland Security [announced](#) its **year-end accomplishments**, including arrest totals for each of its immigration operations.

On January 7, 2026, a **whistleblower report** [revealed](#) an internal **DHS memo** purporting to authorize ICE agents to forcibly enter homes and make arrests with only an administrative warrant.

On January 20, 2026, **DHS announced that ICE** [arrested](#) **7,000 purported gang members** and [deported](#) **more than 675,000 individuals** during the first year of President Trump's second term.

On January 22, 2026, **DHS** [described](#) the Administration's "Enhanced Federal Law Enforcement Training for ICE."

On January 28, 2026, **ICE** [issued](#) a **memo** purporting to expand the power of **immigration agents to arrest noncitizens without an administrative warrant (or a judicial warrant)** by reinterpreting what it means to be "likely to escape before [an administrative] warrant can be obtained for his arrest."

On February 4, 2026, **DHS** [issued](#) a press release and [op-ed](#) defending the legality of **DHS's policy authorizing forcible entry into homes to arrest noncitizens without judicial warrants.**

On February 18, 2026, **DHS issued a new** [memo](#) articulating **U.S. Citizenship and Immigration Services (USCIS) and ICE's Refugee Detention Policy.** In the memo, DHS interprets the Immigration and Nationality Act (INA) to mean a refugee can be detained for an unspecified amount of time if the refugee does not submit an application for lawful permanent resident status and appear for an interview within one year of entering the United States. DHS' policy now requires DHS agents to locate, arrest, and detain refugees who do not file applications and appear for an interview within that period.

Specifically, the lawsuit challenges the May 2025 memorandum issued by Acting Director of ICE Todd Lyons, which claims that ICE may now rely on Form I-205 to enter private residences.

On February 24, 2026, five named plaintiffs who were subjected to a warrantless immigration arrest without probable cause brought [this class action lawsuit](#). They seek to represent a class of individuals who have been or will be subjected to similar warrantless arrests by DHS in North Carolina. In the lawsuit, the plaintiffs challenge DHS's policy of warrantless arrests under the

Administrative Procedure Act (APA) and federal courts' inherent authority, and seek declaratory judgment, vacatur, and injunctive relief.

Legal Challenges

***Tincher v. Noem*, [0:25-cv-04669](#) (D. Minn.)**

On December 17, 2025, the ACLU of Minnesota and three Minneapolis firms filed a [lawsuit](#) challenging the Department of Homeland Security’s systemic violation of First and Fourth Amendment rights in the course of their immigration enforcement operations in the Twin Cities. Plaintiffs allege that the Trump-Vance administration is unduly interfering with First Amendment rights to protest and assemble, claiming that the defendants have pepper sprayed, violently subdued, and aimed assault rifles at protesters and observers, and have even followed observers home to intimidate them. On January 16, 2026, the court entered a preliminary injunction prohibiting federal agents participating in Operation Metro Surge from retaliating against peaceful protesters, including through detention or arrest, use of pepper spray, and other intimidation tactics.

***Minnesota v. Noem*, [0:26-cv-00190](#) (D. Minn.)**

On January 12, 2026, the State of Minnesota and the Cities of Minneapolis and St. Paul filed a [lawsuit](#) challenging the unlawful tactics used by DHS agents during Operation Metro Surge—including the use of force against individuals peacefully protesting; the arrest and threatened use of force against innocent bystanders; the pointing firearms at and use of chokeholds and other restraints against individuals who do not pose a threat to DHS agents; and carrying out enforcement actions at sensitive locations. Plaintiffs allege that the unlawful surge of law enforcement officials to Minnesota violates the Tenth Amendment by infringing on the plaintiffs’ police power, equal sovereignty under the Constitution, city laws and ordinances, and is contrary to numerous federal statutes. Plaintiffs also assert claims under the First Amendment, alleging unconstitutional retaliation and viewpoint discrimination.

Twelve members of the U.S. House of Representatives brought suit to challenge DHS' "oversight visit policy," which required at least seven days' advance notice for congressional oversight visits to DHS and ICE detention facilities and restricted access to certain facilities, including ICE field offices. Plaintiffs allege this policy is unlawful under the APA because, among other things, it is contrary to Section 527 of DHS' fiscal year 2024 appropriations law (as carried forward into FY 2025) and is arbitrary and capricious.

The court [preliminarily stayed](#) the DHS policy in December. After the fatal shooting of a U.S. citizen by a federal agent in Minneapolis, DHS Secretary Kristi Noem reinstated the requirement through a new memorandum that came to light only after multiple members of Congress were denied entry to an ICE facility in Minneapolis. After plaintiffs filed an [amended complaint](#), adding an additional member plaintiff from Minnesota, and a [motion for temporary restraining order](#) to challenge the updated memo, the court granted a [temporary restraining order](#), requiring defendants to temporarily restore access to the facility for unannounced oversight visits for plaintiffs.

***Fridley Public School District v. Noem*, [0:26-cv-01023](#) (D. Minn.)**

On February 4, 2026, a coalition of Minnesota school districts and educators filed [suit](#) seeking to block the Trump-Vance administration from conducting immigration enforcement activities in or near public schools. The lawsuit challenges DHS’s decision to remove longstanding protections that limited immigration enforcement activities at “sensitive locations,” such as schools. Plaintiffs argue recent federal immigration enforcement actions have disrupted education, endangered students, and driven families away from their schools. The plaintiffs allege that these actions violate the APA and seek injunctive relief to prevent these operations from continuing.

***Minneapolis Area Synod of the Evangelical Lutheran Church in America v. U.S. Department of Homeland Security*, [0:26-cv-01576](#) (D. Minn.)**

On February 23, 2026, a coalition of congregations and clergy across Minnesota filed suit to challenge DHS and ICE’s policy and practice of prohibiting plaintiffs from entering an immigration detention facility and providing pastoral care to hundreds of individuals detained at the Bishop Henry Whipple Building (“Whipple”). Plaintiffs allege the prohibition violates the First Amendment and the Religious Freedom Restoration Act.

On February 27, 2026, a coalition seeking to represent a class of refugees brought [suit](#) to challenge DHS’s “[Refugee Detention Policy](#).” The policy directs the warrantless arrest and mandatory detention (that is potentially indefinite) of lawfully-admitted refugees who have lived in the United States for at least one year and have not yet adjusted their resident status. Plaintiffs argue that this policy violates the APA because it violates the INA, was issued without required notice-and-comment rulemaking, is arbitrary and capricious, and violates the Fourth and the Fifth Amendments.

On March 24, 2026, the State of Minnesota, Hennepin County, and the Minnesota Bureau of brought [suit](#) to challenge the actions taken by the federal government to stonewall Minnesota’s investigation into the killings of Alex Pretti and Renee Good. Executive Actions

On August 13, 2025, **Attorney General Bondi sent a demand letter to [Mayor Johnson](#) and [Governor Pritzker](#)** notifying them that their jurisdiction had been identified as one that engages in sanctuary policies and demanding that they submit a response to the letter by August 19, 2025.

On September 8, 2025, **ICE launched [Operation Midway Blitz](#)**, prompting large-scale ICE **[demonstrations and protests](#)**.

On September 26, 2025, **[DHS sent a memo](#)¹ requesting assistance from the Department of Defense (DOD)** for federal facility protection support in Illinois.

On October 4, 2025, President Trump issued a **Presidential Memorandum: “[Department of War Security for the Protection of Federal Personnel and Property in Illinois](#),”** in which he called **[300 members](#)**² of the Illinois National Guard into federal service in response to the supposed “coordinated assault by violent groups” at ICE and Federal Protective Services (FPS) facilities in Illinois.

On October 4, 2025, Defense Secretary Hegseth **issued two memos directing [300 members](#) of the Illinois National Guard and [200 members](#) of the Texas National Guard to Chicago.**

As of January 6, 2026, **[U.S. Northern Command announced](#) that all Title 10 troops (that is, federalized National Guard) in Portland, Los Angeles, and Chicago are conducting demobilizing activities** and will return to their home units once demobilization is complete.

As of January 21, 2026, **[U.S. Northern Command announced](#) that all Title 10 troops in Portland, Los Angeles, and Chicago have completed demobilizing activities.**

On October 6, 2025, the State of Illinois and the City of Chicago filed a [complaint](#) seeking to stop President Trump’s federalization of the Illinois National Guard and deployment of the Texas National Guard to Chicago. Plaintiffs argued that the administration acted in excess of its authority to federalize Guard troops under 10 U.S.C. § 12406, and that it violated the Posse Comitatus Act, the APA, the Tenth Amendment, and provisions of the Constitution protecting equal sovereignty among states.

On December 23, 2025, the Supreme Court [ruled](#) 6-3 to deny the government’s application to stay a temporary restraining order entered by the District Court, which barred the federalization and deployment of the National Guard. The Court held that “the term ‘regular forces’ in §12406(3) likely refers to the regular forces of the United States military. This interpretation means that to call the Guard into active federal service under §12406(3), the President must be ‘unable’ *with the regular military* ‘to execute the laws of the United States,” and further concluded that the government had failed, at this preliminary stage, to identify a source of authority that would allow the military to execute the laws in Illinois.

Executive Actions

On June 7, 2025, Defense Secretary Hegseth issued a [memo](#) calling forth **2,000 members of the California National Guard** into federal service for a period of 60 days on the basis of the **Presidential Memorandum, “[Department of Defense Security for the Protection of Department of Homeland Security Functions](#)”** that President Trump had issued the same day.

On June 9, 2025, Defense Secretary Hegseth issued [another memo](#) calling forth an **additional 2,000 members** of the California National Guard into federal service and [700 Marines](#).

On June 11, 2025, [U.S. Northern Command announced](#) that, at the direction of Defense Secretary Hegseth, approximately 4,000 California Army National Guard soldiers and 700 Marines were **placed under federal command and control in a Title 10 status**.

On July 16, 2025, the [Pentagon announced](#) it would **end the deployment of 2,000 National Guard troops** in Los Angeles.

On July 21, 2025, the [Pentagon announced](#) it would **end the deployment of 700 Marines**.

As of January 6, 2026, [U.S. Northern Command announced](#) that **all Title 10 troops (that is, federalized National Guard) in Portland, Los Angeles, and Chicago are conducting demobilizing activities** and will return to their home units once demobilization is complete.

Legal Challenges

***Newsom v. Trump*, 3:25-cv-04870 (N.D. Cal.), 25-5553 (9th Cir.)**

On June 9, 2025, California Governor Gavin Newsom filed suit against President Trump, Defense Secretary Hegseth, and DOD in the Northern District of California, challenging the administration’s decision to federalize 4,000 members of the California National Guard. In the [complaint](#), Newsom argued that federalization of the California National Guard in these circumstances violates 10 U.S.C. § 12406 because the order did not go through the Governor and

because the factual prerequisites for federalization had not been met, along with the Tenth Amendment and the APA.

Memphis, TN

Executive Actions

On September 15, 2025, **President Trump issued the Presidential Memorandum: “[Restoring Law and Order in Memphis](#),”** establishing a task force to “end street and violent crime in Memphis to the greatest extent possible through the promotion and facilitation of hypervigilant policing, aggressive prosecution, complex investigations, financial enforcement, and large-scale saturation of besieged neighborhoods with law enforcement personnel.” The Memorandum also directed Defense Secretary Hegseth to request that the Governor of Tennessee mobilize the state’s Guard.

Also on September 15, 2025, **[Tennessee Governor Bill Lee met with President Trump](#)** in the Oval Office “to request that President Trump grant activation of the Tennessee National Guard under Title 32 orders.”

On September 26, 2025, **Governor Lee [announced](#) that personnel from 13 U.S. agencies**, including the FBI, the DEA, and AFT, as well as 300 troopers from the Tennessee Highway Patrol, would begin patrolling Memphis on September 29, 2025. He also referred to deploying the state National Guard in support roles, without authority to make arrests.

On [October 10, 2025](#), **the National Guard began [patrolling](#) Memphis**. The Governor never specified roles or duties for the National Guard within the Task Force (e.g., the ability to make arrests) nor the duration of the deployment. And despite promising that National Guard personnel would remain unarmed, citizens reported sighting armed National Guard members as early as October 11, 2025.

Legal Challenges

On October 17, 2025, seven Tennessee elected officials at the city, county, and state levels filed a state-law [lawsuit](#) challenging Governor Lee’s deployment of the Tennessee National Guard to the city of Memphis at the request of President Trump as a violation of the Tennessee Constitution and state law. The Court ruled that the deployment was unlawful in violation of Tennessee law. The Tennessee government has appealed. Updates on the case can be found [here](#).

Portland, OR

Executive Actions

On September 26, 2025, [DHS sent a memo](#) requesting assistance from the DOD for federal facility protection support in Oregon.

On September 27, 2025, **President Trump posted on [Truth Social](#)**: “At the request of Secretary of Homeland Security, Kristi Noem, I am directing Secretary of War, Pete Hegseth, to provide all necessary Troops to protect War ravaged Portland, and any of our ICE Facilities under siege from attack by Antifa, and other domestic terrorists. I am also authorizing Full Force, if necessary. Thank you for your attention to this matter!”

On September 27, 2025, the Acting Vice Chief of the National Guard transmitted a [memo to the Adjutant General of the Oregon National Guard](#), requesting that 200 members of the Oregon National Guard mobilize in Title 32 status in the next 12 hours.

On September 28, 2025, **Defense Secretary Hegseth issued a [memo](#)** deploying 200 members of the Oregon National Guard into federal service in Title 10 status for a period of 60 days.

On or about October 4, 2025, **Defense Secretary Hegseth called [400 members](#)** of the Texas National Guard to perform missions in Portland and Chicago and attempted to deploy [200 members of the California National Guard](#) to Portland, after an Oregon judge had blocked the deployment of the Oregon National Guard in the state.

As of January 6, 2026, [U.S. Northern Command announced](#) that **all Title 10 troops (that is, federalized National Guard) in Portland, Los Angeles, and Chicago are conducting demobilizing activities** and will return to their home units once demobilization is complete.

Washington, DC

Executive Actions

On August 11, 2025, **President Trump issued Executive Order (EO) 14133, “[Declaring a Crime Emergency in the District of Columbia](#)”**, in which he commandeered the Metropolitan Police Department (MPD) for “Federal purposes, including maintaining law and order in the Nation’s seat of Government; protecting Federal buildings national monuments, and other Federal property; and ensuring conditions necessary for the orderly functioning of the Federal Government.”

That same day, **President Trump issued a Presidential Memorandum to the Secretary of Defense: “[Restoring Law and Order in the District of Columbia](#).”**

On August 14, 2025, **Attorney General Bondi issued Order No. 6370-2025, “[Restoring Safety and Security to the District of Columbia](#),”** appointing the Administrator of the Drug Enforcement Administration to serve as MPD’s Emergency Police Commissioner for the duration of the emergency pursuant to D.C. Code § 1-207.40.

That same day, **DOD announced that the National Guard mobilized [800 troops](#) to D.C.**

On August 15, 2025, **Attorney General Bondi rescinded [Order No. 6370-2025](#), and issued [Order No. 6372-2025](#),** instructing the D.C. Mayor to provide for “assistance with the enforcement of federal immigration law” notwithstanding existing MPD policies.

On August 23, 2025, **the D.C. National Guard announced the deployment of [1,900 guardsmen](#)** from the D.C., West Virginia, South Carolina, Ohio, Mississippi, Louisiana, and Tennessee National Guards. The D.C. National Guard was also [authorized to carry weapons](#) in support of law enforcement. Defense Secretary Hegseth signed an order [authorizing the carrying of weapons](#), which was approved by the U.S. Marshals Service.

On August 28, 2025, **President Trump issued EO 14339, “[Additional Measures to Address the Crime Emergency in the District of Columbia](#),”** instructing the National Park Service and the U.S. Attorney’s Office of the District of Columbia to increase law enforcement and prosecutors to support public safety in Washington, D.C. It also directed the Secretary of Defense to create a specialized D.C. National Guard unit; asked the Department of Housing and Urban Development (HUD) to investigate any non-compliance with crime prevention and safety requirements in HUD’s agreements with D.C. Housing Authority; and tasked the Secretary of Transportation with conducting safety inspections in federally funded transit services.

On September 3, 2025, Army Secretary Dan Driscoll signed off on a plan to [extend orders](#) for the D.C. National Guard to remain on active duty through November 30, 2025.

October 30, 2025, Secretary Hegseth **ordered the extension** of the National Guard deployment in D.C. until at least February 2026.

Legal Challenges

District of Columbia v. Trump, 1:25-cv-02678 (D.D.C.) - voluntarily dismissed

On August 15, 2025, D.C. filed a [complaint](#) challenging EO 14333, which invoked authorities under the Home Rule Act and D.C. Code § 1-207.40 to declare an emergency in D.C. and commandeer the D.C. Police, as well as Attorney General Order No. 6370-2025. D.C. alleged the Trump-Vance administration violated the APA, the Home Rule Act, and the Constitution (separation of powers, Take Care Clause, District Clause).

The District filed a [motion for TRO](#), which it ultimately [withdrew](#) after the Attorney General subsequently rescinded Order No. 6370-2025. On September 10, 2025, President Trump's invocation of D.C. Code § 1-207.40 expired. On September 25, 2025, D.C. filed a [notice of voluntary dismissal](#), which the court granted.

District of Columbia v. Trump, 1:25-cv-03005 (D.D.C.)

On September 4, 2025, D.C. filed [a complaint](#) challenging the deployment of National Guard troops without the District's consent, arguing the deployment violates the APA, the Constitution (separation of powers, Take Care Clause, District Clause, Militia Clauses), the Home Rule Act, the Emergency Management Assistance Compact, the Posse Comitatus Act, and 10 U.S.C. § 275.

On October 23, 2025, the ACLU of the District of Columbia filed a [lawsuit](#) against multiple police officers and National Guard members on behalf of a plaintiff who alleges that an Ohio National Guard member violated his constitutional rights by calling D.C. police to prevent him from protesting and recording the National Guard's conduct. The plaintiff asserts First and Fourth Amendment claims under 42 U.S.C. § 1983, as well as several common law tort claims.

S. Carolina Public Interest Foundation v. McMaster, (S.C. Sup. Ct.)

On January 7, 2026, the South Carolina Public Interest Foundation and a South Carolina resident filed a [lawsuit](#) in state court challenging Gov. McMaster's deployment of state National Guard troops to Washington, D.C. at the request of President Trump. Plaintiffs argue that South Carolina law does not allow the governor to "support federal law enforcement activities" outside of the state under Title 32 of the U.S. Code, and the lawsuit seeks to block the ongoing deployment. This case was filed [directly](#) in the South Carolina Supreme Court, which has original jurisdiction over the matter.
